If you choose to proceed with a Dissolution of Marriage, Motion to Modify Child Custody, Child Support, a Motion for Family Access, Petition for Child Custody, Petition for Paternity, or a Petition for Change of Name as a pro-se litigant, it is the requirement of this court, pursuant to Local Court Rule 68.7, that you shall use the pleading forms found at www.selfrepresent.mo.gov. According to Supreme Court Rule 88.09 you must successfully complete the Litigant Awareness Program. You can go to www.selfrepresent.mo.gov and then click the link Litigant Awareness Program. Further, it is a requirement that you present your certificate of completion with the court prior to the first court hearing of the process you are pursuing.

Please refer to the following checklist when attempting to represent yourself in a Dissolution of Marriage, Motion to Modify, Motion for Family Access, Petition for Child Custody, Petition for Paternity, and a Petition for Change of Name. You should be prepared to present the following documents at the time of filing.
